### The application of mother tongue education

The right to education in the mother tongue for multi-lingual students in elementary school and high school, is as follows:

1. At least one parent is from a foreign country
2. The language is a living language, and used on a daily basis at home
3. The student has received mother tongue education less than seven school years
4. The pupil is an adopted child with a mother tongue other than Swedish

Although the headmaster decided that the student has the right to mother-tongue teaching, It can in some cases be that teaching cannot be started. It applies if:

- (a) there are fewer than five students whose parents requested, with the exception of the national minority languages
- b) suitable teacher is missing

### The application of mother tongue education

The application is made, until first of June, for teaching beginning in August and for one academic year. The application must be made every year. New student applies as soon as possible. The application is submitted to the appropriate school principal who decides on the basis of submitted documents and which sends it to the Coordinator of mother tongue teaching in which the final decision is taken. Decisions are sent to parents by letter.

### Offer of mother tongue education

Groupsize: five students/language is the benchmark, but deviations may occur.

Classroom: In some languages there might be a small amount of students, therefore the education can be located at a different school in Hylte municipality. School bus is not offered due to mother tongue education is a voluntary activity. The teaching follows the academic year hours in Hylte municipality. The teaching is free of charge and some educational materials are included
